## REVOCATION OF THE SUSPENSION OF OPEN BURNING AND OTHER OPEN FIRES

Due to lowering temperatures and increase of precipitation throughout the County of San Bernardino, I hereby revoke the suspension of all open burning and other open fires in the following geographic areas pursuant to San Bernardino County Fire Protection Ordinance §26:

- **Division 1 – All unincorporated West Valley areas, as well as the Cities of Fontana and Upland.**
- **Division 2 – All unincorporated East Valley areas, as well as the Cities of San Bernardino and Grand Terrace.**
- **Division 3 – All Mountain Areas, except for within the Running Springs Fire District and the Big Bear Fire Authority boundaries.**
- **Division 4 – All unincorporated South Desert and River Areas, as well as the Town of Yucca Valley, the City of 29 Palms, and the City of Needles, with the exception of Morongo Valley.**
- **Division 5 – All unincorporated High Desert Areas, as well as the City of Hesperia.**
- **Division 6 – All unincorporated North Desert Areas, as well as the City of Adelanto.**

**THIS REVOCATION OF BURN SUSPENSION SHALL TAKE EFFECT AT  
0800 HOURS, MONDAY, JANUARY 25, 2021**

### PLEASE NOTE:

- A permit is required for conducting any open fire for the purposes of residential or agricultural burning within the San Bernardino County Fire Protection District. Please contact Office of the Fire Marshal or visit [www.sbcfire.org](http://www.sbcfire.org) for information on how to obtain an Open Fire permit.
- Covered barbecues as well as recreational fires are exempt from permit. Such fires must be fueled solely by natural gas or propane within wildfire risk areas.
- A permit is required for open fires conducted in the course of filming, public fireworks displays, or for bonfires at ceremonial events. Please contact Office of the Fire Marshal or visit [www.sbcfire.org](http://www.sbcfire.org) for information on how to obtain a Special Event permit. Such open fires shall be conducted by a licensed professional or other responsible person, and inspected by fire department personnel, who shall determine that local climactic conditions are safe.
- Per the South Coast Air Quality Management District, residential burning of trash, yard clippings and tree trimmings are **ALWAYS** prohibited in the Mountain and Valley areas regardless of conditions.
- Regardless of location or permit conditions, **ALL** open fires (except for fires fueled solely by natural gas or propane) must be extinguished during Red Flag or Fire Weather Watch Conditions, when local winds exceed 10 miles per hour or when directed by Fire Department personnel.
- Please check with CalFire within State Responsibility Areas, the United States Forest Service (USFS) within the Angeles and San Bernardino National Forests, or the Bureau of Land Management (BLM) within outlying desert regions for additional restrictions and permitting requirements.

**Unlawful fires may result in administrative or legal action against the person kindling the fire and/or the owner of the property on which the fire occurs.**
