# Overtaken truck with trailer in Hesperia resulted in major traffic on the SB I-15

HESPERIA, Calif. (VVNG.com) — An overturned truck with a trailer in Hesperia resulted in major traffic delays for motorists traveling on the I-15 freeway Wednesday.

The accident was reported at 2:55 pm, on October 26, 2022, almost directly underneath the Rancho Road overpass and near the freeway on-ramp.

A Dodge Ram was transporting another pickup truck on top of a car hauler when it overturned, blocking the no. 3 and no. 4 lanes.

**San Bernardino County Fire** responded to the incident and checked out the driver of the truck who was determined not to be injured.

The Rancho Road on-ramp was temporarily blocked while the tow truck drivers worked on loading the vehicles. CalTrans was informed of a sign that was down on the onramp.

Southbound Mariposa Road was gridlocked for several hours as motorists attempted to use it as a detour. Traffic on the I-15 southbound started flowing freely again at about 7:00 pm.

The Victorville California Highway Patrol is handling the investigation.

# Pedestrian struck and killed on Phelan Road near Caughlin Road

PHELAN, Calif. (VVNG.com) — The California Highway Patrol is investigating a fatal accident involving a pedestrian and a semi.

It happened at about 8:17 pm, on Wednesday, October 26, 2022, on Phelan Road, just east of Caughling Road.

According to the California Highway Patrol incident logs, two off-duty firefighters reported it was obvious the pedestrian was deceased. **San Bernardino County Fire** personnel arrived and confirmed the death.

The pedestrian's body was covered with a yellow sheet near the shoulder of the roadway. The San Bernardino County Coroner was advised to respond to retrieve the body.

Two tractor-trailer semis that were traveling eastbound on Phelan Road stopped at the scene. CHP officers conducting the investigation used a flashlight to light up the front of one of the semis.

The investigation is ongoing and additional information will be updated as it becomes available.
